2008 UMAC MEN'S TENNIS CHAMPIONSHIP DAY 2 REVIEW

College of St. Scholastica Wins Eighth Post-Season Championship

April 26, Minneapolis, Minn. – The College of St. Scholastica men's tennis team stormed through the second day of competition at the 2008 Upper Midwest Athletic Conference (UMAC) post-season tournament, sweeping all six singles flights to secure the post-season title. The Saints trailed Northwestern College by just one point heading into the day, but St. Scholastica held off second-place finisher Northwestern along with the other conference opponents to claim their eighth UMAC post-season championship in program history. The two-day event was held at the University of Minnesota *Baseline Tennis Center* in Minneapolis.
